This report provides a summary of many arrests, incidents, events and other items of significance occurring in Bloomfield Township. However, it does not include every incident reported to the Police Department. It is possible for publicity to hinder some criminal investigations. In these situations, we do not release information unless it is in the community's best interest or we are certain it will not compromise an investigation.

Summary:

During the timeframe of August 4, 2025, through August 10, 2025, Bloomfield Township Officers handled 503 calls for service, 163 of which were traffic stops.

Traffic Crashes:

Officers investigated 35 total traffic crashes during this timeframe: 17 Property Damage Crashes, 7 Personal Injury Crashes, 7 Hit and Run Crashes, 3 Private Property Crashes, 1 Car vs. Deer Crash, and 0 Non-UD-10 Crashes.

Retail Fraud

4099 Telegraph Road (Kroger)

On August 9, 2025, at approximately 3:00 p.m., the Bloomfield Township Police Department responded to the Kroger located at 4099 Telegraph Road for a Retail Fraud in progress. Store employees observed a black male wearing a white shirt and black shorts load a cart full of Red Bulls, Canada Dry, Sprite, and other drinks into a cart and leave the store without paying. The male was seen loading the merchandise into a white van and leaving the area. Officers located the van on the north side of the shopping plaza and observed the stolen merchandise inside. Officers also located a suspect, a juvenile, and placed him under arrest. A second suspect, the driver of the van, fled the scene on foot, but was later apprehended by Bloomfield Township Police. The second subject was identified as COREY DEANNE MARTIN, a 27-year-old male out of Inkster. A total of \$424.99 worth of merchandise was recovered and returned to Kroger. This case was sent to the Oakland County Prosecutor's Office who reviewed it and issued a one-count warrant for Retail Fraud in the First Degree. MARTIN was arraigned at the 52-1 District Court where he was given a \$15,000/10% bond. A petition request was sent to the Juvenile Circuit Court for the Juvenile involved.

Retail Fraud
2105 Telegraph Road (Dick's Sporting Goods)

On August 6, 2025, at approximately 1:00 p.m., the Bloomfield Township Police Department was dispatched to a Retail Fraud that had just occurred at Dick's Sporting Goods located at 2105 Telegraph Road. Two black male suspects entered the store and grabbed multiple pieces of Nike merchandise, went to the fitting room, and left the store with the merchandise concealed. The suspects were seen leaving the area in a blue Chrysler minivan. Officers located the vehicle and conducted a traffic stop. The two suspects, identified as AARON JAMAL DALTON, a 30-year-old male out of Detroit, and LOUIS PERRI MCSHAN, a 28-year-old male out of Detroit, were placed under arrest for Retail Fraud. The stolen merchandise, totaling \$369.99, was recovered from inside the vehicle and returned to Dick's Sporting Goods. A five-inch folding knife was also recovered from DALTON's property. This case was sent to the Oakland County Prosecutor's Office who reviewed it and issued the following charges:

- AARON JAMAL DALTON-one count Carrying Concealed Weapon, one count Retail Fraud Second Degree, and one count Driving While License Suspended.
- LOUIS PERRI MCSHAN- one count Retail Fraud Second Degree

Both individuals were arraigned at the 48th District Court. DALTON was issued a \$25,000 cash bond (no 10%) and MCSHAN was issued a \$10,000 cash bond (no 10%). They are due back in court next week.
