This report provides a summary of many arrests, incidents, events and other items of significance occurring in Bloomfield Township. However, it does not include every incident reported to the Police Department. It is possible for publicity to hinder some criminal investigations. In these situations, we do not release information unless it is in the community's best interest or we are certain it will not compromise an investigation.

Summary:

During the timeframe of August 25, 2025, through August 31, 2025, Bloomfield Township Officers handled 322 calls for service, 57 of which were traffic stops.

Traffic Crashes:

Officers investigated 28 total traffic crashes during this timeframe: 13 Property Damage Crashes, 6 Personal Injury Crashes, 2 Hit and Run Crashes, 4 Private Property Crashes, 2 Car vs. Deer Crashes, and 1 Non-UD-10 Crash.

25-17978 Retail Fraud

2501 S Telegraph Road (Dick's Sporting Goods)

On August 30, 2025, the Bloomfield Township Police Department was dispatched to Dick's Sporting Goods located at 2501 S Telegraph Road for a Retail Fraud that just occurred. The suspect, an unknown black male, entered the store at approximately 12:30 p.m. and was seen placing multiple packs of boxer briefs, valued at \$237.00, into a black Nike backpack. The suspect left the store failing to pay for the items. Store employees observed the suspect leave the area in a red hatchback. This case was turned over to the Bloomfield Township Investigations Unit and is currently under investigation. 25-17864 Retail Fraud

2400 S. Telegraph Road (Target)

On August 28, 2025, the Bloomfield Township Police Department responded to Target located at 2400 S Telegraph Road for a Retail Fraud that just occurred. Target's Loss Prevention team was out with a female who attempted to walk out of the store without paying for two Dentek Pro-Fit guards and a fifteen pack of Huggies wipes. The merchandise totaled \$70.47 and was recovered on the scene. The female was issued a misdemeanor citation for Retail Fraud and was trespassed from the store.

Larceny from AutomobileBloomfield Township

On August 27, 2025, the Bloomfield Township Police Department took multiple reports for Larceny from Automobiles that occurred the night prior. The vehicles were left unlocked and personal property was stolen. The Bloomfield Township Police Department reminds all of our residents to lock their car doors and not to leave anything of value inside.

25-17696 Vehicle Theft 500 block of N. Foxhills Drive

On August 26, 2025, the Bloomfield Township Police Department took a report of a stolen vehicle from the area of 500 N. Fox Hills Drive. The victim arrived at her residence at approximately 2:05 p.m. and left the vehicle, a white Jeep Cherokee, running and the doors unlocked while she entered her home. At 2:15 p.m. the victim noticed that her vehicle was gone. On the same date at approximately 10:30 p.m., the Oakland County Sheriff's department initiated a traffic stop on the stolen vehicle in the area of Opdyke and South Boulevard. Multiple suspects were taken into custody and the vehicle was recovered.
